RESOLUTION NO. SP- **7075**, S-2017

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M BAUTISTA, TO PROCURE TWELVE (12) UNITS OF MOTORIZED VEHICLE TO BE UTILIZED BY THE DEPARTMENT OF THE BUILDING OFFICIAL (DBO), QUEZON CITY GOVERNMENT (QCG), FOR THE EFFECTIVE IMPLEMENTATION, OPERATION AND MONITORING OF PROGRAMS AND PROJECTS OF THE CITY, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.

WHEREAS, pursuant to Section 455 (b) (1) (vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, "the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance";

WHEREAS, under Section 455 (4) of the same Code, "the City Mayor Ensure the delivery of basic services and the provision of adequate facilities as provided for under Section 17 of this Code and, in addition thereto, shall: x

- (i) *Ensure that the construction and repair of roads and highways funded by the national government shall be, as far as practicable, carried out in a spatially contiguous manner and in coordination with the construction and repair of the roads and bridges of the city, x.x.x;*
- (ii) *Coordinate the implementation of technical services, including public works and infrastructure programs, rendered by national offices in the case of highly urbanized and independent component cities, and by national and provincial offices in the case of component cities."*

WHEREAS, the Commission on Audit (COA) issued Audit Observation Memorandum 2014-11-C, S-2013, "requiring the City Council to give prior authorization to the City Mayor before any expenses/disbursements charged against a lump sum appropriation can be made" citing the case of Hon. Gabriel Quisimbing vs Hon. Gwendolyn F. Garcia (GR No 175527) of the Supreme Court as basis;

WHEREAS, a request was made by the Department of the Building Official (DBO), Quezon City Government (QCG), to procure twelve (12) units of motor vehicle to be utilized for the mobility in the conduct of inspections, and improving of service and productivity, efficiency and capabilities;

WHEREAS, the motor vehicle requested shall have the following specifications, to wit:

WHEREAS, the City Council hereby authorizes Mayor Herbert M Bautista, to grant the request to procure Twelve (12) units of motorized Vehicle, to assist in the effective implementation, operation and monitoring of the programs and projects of the city, subject to existing laws, rules and regulations.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to procure twelve (12) units of motorized vehicle to be utilized by the Department of the Building Official (DBO), Quezon City Government (QCG), for the effective implementation, operation and monitoring of programs and projects of the city, subject to existing Laws, Rules and Regulations."


