A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ACCEPT THE DEED OF DONATION AND ACCEPTANCE EXECUTED BY FERN REALTY CORPORATION REPRESENTED BY ITS PRESIDENT ANTONIO R. MONTINOLA COMPOSED OF ONE (1) OPEN SPACE, THREE (3) EASEMENTS, SIX (6) ALLEYS AND FIFTEEN (15) ROAD LOTS OF FERN VILLAGE LOCATED AT BARANGAY PASONG TAMO, QUEZON CITY.

WHEREAS, Fern Realty Corporation is the registered owner of certain parcels of land located inside Fern Village at Barangay Pasong Tamo, Quezon City, consisting of alleys, roads, open space and easements;
