*WHEREAS, petitioner Unioil Petroleum Phils., Inc., a business entity duly registered under Philippine Laws, is applying for a Special Use Permit (SUP) to be used for the construction and operation of a gasoline filling station located along Katipunan Avenue, Barangay St. Ignatius, Quezon City;*

*WHEREAS, fuel stations are among the uses that require Special Use Permit upon authorization from the Quezon City Council pursuant to the Quezon City Comprehensive Zoning Ordinance; X*


WHEREAS, Unioil Petroleum Phils., Inc. has complied with the necessary requirements for the issuance of a Special Use Permit as mandated by the aforementioned Quezon City Comprehensive Zoning Ordinance;

WHEREAS, the construction and operation of a gas station will provide employment and promote economic development in the City.


