A RESOLUTION URGING THE QUEZON CITY GOVERNMENT TO INCLUDE THE SEVEN HUNDRED THIRTY FIVE SQUARE METERS AND SEVENTY SQUARE DECIMETERS (735.70) PROPERTY, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 40770, DESCRIBED AS LOT 16, BLOCK 3 BATAAN ROAD GARCIA HEIGHTS, BARANGAY HOLY SPIRIT, QUEZON CITY, AS AREA OF PRIORITY DEVELOPMENT, IN THE INTEREST OF THE RESIDENTS THEREAT.

WHEREAS, the members of the Bataan Ville Homeowners Association, Inc. are the present occupants of the said parcel of land and are willing to purchase the same through Community Mortgage Program.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge the Quezon City Government to include the Seven Hundred Thirty Five Square Meters and Seventy Square Decimeters (735.70) property, covered by Transfer Certificate of Title No. 40770, described as Lot 16 Block 3 Bataan Road Garcia Heights, Barangay Holy Spirit, Quezon City, as Area of Priority Development in the interest of the existing residents thereat.
