A RESOLUTION URGING THE QUEZON CITY GOVERNMENT TO INCLUDE LOTS 9, 10 AND 11 OF BLOCK 4 CORREGIDOR STREET, GARCIA HEIGHTS, BARANGAY HOLY SPIRIT, QUEZON CITY, AS AREA OF PRIORITY DEVELOPMENT IN THE INTEREST OF EXISTING RESIDENTS THEREAT.

WHEREAS, there exists a parcel of land with an aggregate area of One Thousand Five Hundred Seventy Two square meters and Ninety square decimeters (1572.90 sq.m.) located at Lots 9, 10 and 11 of Block 4 Corregidor Street, Garcia Heights, Barangay Holy Spirit, Quezon City;

WHEREAS, the Luzon Development Bank is the owner of the property with an aggregate area of One Thousand Five Hundred Seventy Two square meters and Ninety square decimeters (1572.90 sq.m.) registered in the Registry of Deeds of Quezon City under TCT Nos. 40772, 40773 and 40774;


NOW, THEREFORE,


