WHEREAS, the Luzon Development Bank is the owner of the property with an aggregate area of One Thousand Five Hundred Seventy Two square meters and Ninety square decimeters (1572.90 sq.m.) registered in the Registry of Deeds of Quezon City under TCT Nos. 40772, 40773 and 40774;
