RESOLUTION NO. SP- 7094 , S-2017

A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO DIAMOND V EIGHT TRANSPORT INC., FOR THE CONSTRUCTION AND OPERATION OF A BUS GARAGE AND ONE STOREY MAINTENANCES ROOM WITH QUARTERS AND MOTORPOOL LOCATED AT NO. 1047 QUIRINO HIGHWAY, BARANGAY STA. MONICA, QUEZON CITY.

WHEREAS, Diamond V Eight Transport, Inc. is applying for a Special Use Permit for the construction and operation of a Bus Garage and One Storey Maintenances Room with Quarters and Motorpools located at No. 1047 Quirino Highway, Barangay Sta. Monica, Quezon City;

WHEREAS, in accordance with the provision of Article VII Section 2 of Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance and its Implementing Rules and Regulations, a Special Use Permit is required for this project;

WHEREAS, the proposed project will not adversely affect the public health, safety and welfare of the citizenry. It will also provide and promote livelihood;

WHEREAS, the applicant has complied with all the requirements for the issuance of a Special Use Permit and Barangay Sta. Monica interposes no objection on the operation of the applicant's bus garage and approves the conduct of its business in their area.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the issuance of a Special Use Permit to Diamond V Eight Transport Inc., for the construction and operation of a Bus Garage and One-Storey Maintenances Room with Quarters and Motorpool located at No. 1047 Quirino Highway, Barangay Sta. Monica, Quezon City.

RESOLVED, FURTHER, that the applicant, Diamond V Eight Transport Inc., shall comply with Section 1 of Ordinance No. SP-2568, S-2017, otherwise known as, "An Ordinance providing for additional terms and conditions in connection with the authority granted by the Quezon City Council for the issuance of a Special Use Permit to operate transport terminals and/or garages in Quezon City," and other pertinent laws.

RESOLVED, FINALLY, that this measure granting Special Use Permit shall be effective for three (3) years from the adoption.
