WHEREAS, Safeway Bus Line, Inc. – Branch is applying for a Special Use Permit for the construction and operation of a Bus Garage and One-Storey Office with Motorpools located at No. 1104 Quirino Highway, Barangay Kaligayahan, Quezon City;

WHEREAS, in accordance with the provision of Article VII Section 2 of Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance and its Implementing Rules and Regulations, a Special Use Permit is required for this project;

WHEREAS, the applicant has complied with all the requirements for the issuance of a Special Use Permit and Barangay Kaligayahan interposes no objection on the operation of the applicant's bus garage and approves the conduct of its business in their area.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the issuance of a Special Use Permit to Safeway Bus Line Inc. – Branch, for the construction and operation of a Bus Garage and One-Storey Office with Motorpool located at No. 1104 Quirino Highway, Barangay Kaligayahan, Quezon City.

RESOLVED, FURTHER, that the applicant, Safeway Bus Line Inc. – Branch, shall comply with Section 1 of Ordinance No. SP-2568, S-2017, otherwise known as, "An Ordinance providing for additional terms and conditions in connection with the authority granted by the Quezon City Council for the issuance of a Special Use Permit to operate transport terminals and/or garages in Quezon City," and other pertinent laws.

RESOLVED, FINALLY, that this measure granting Special Use Permit shall be effective for three (3) years from the adoption.
