RESOLUTION NO. SP- **7096**, S-2017

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO EXTEND RELOCATION ASSISTANCE TO THE FIRE AFFECTED INFORMAL SETTLER FAMILIES (ISFs) AT NATIONAL HOUSING AUTHORITY (NHA) PROPERTY ALONG NIA ROAD, BARANGAY PINYAHAN, QUEZON CITY, IN THE AMOUNT OF FIVE THOUSAND PESOS (PHP5,000.00) PER QUALIFIED FAMILY TO BE TAKEN FROM ANY AVAILABLE FUND OF THE OFFICE OF THE CITY MAYOR IN ACCORDANCE WITH SECTION 28 OF REPUBLIC ACT NO. 7279, OTHERWISE KNOWN AS THE URBAN DEVELOPMENT AND HOUSING ACT OF 1992.

WHEREAS, on December 27, 2016, a fire incident happened at NHA property located along NIA Road, Barangay Pinyahan, Quezon City, affecting 621 informal settler families (ISFs);

WHEREAS, the said NHA property, with an area of more or less 2.1 hectares and classified as institutional - commercial, is fully occupied by ISFs and was already hit by fire four times before the said incident;

WHEREAS, the Inter-Agency Committee, comprising of the NHA, LGU-QC, PCUP, CHR, DILG, HUDCC and Cabinet Secretary (CAB SEC), declared that the area is highly dangerous and no longer suitable for habitation;

WHEREAS, the fire affected ISFs shall be relocated by NHA to its settlement site. Thus, they are no longer allowed to construct their houses inside the area;

WHEREAS, the Quezon City Government shall extend relocation assistance to the Six Hundred and Twenty One (621) ISFs affected by fire, in the amount of Five Thousand Pesos (Php5,000.00) per qualified family so that they may have something to start with and compensate their adjustment at the relocation site.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to extend relocation assistance to the fire affected informal settler families (ISFs) at National Housing Authority (NHA) property along NIA Road, Barangay Pinyahan, Quezon City, in the amount of Five Thousand Pesos (Php5,000.00) per qualified family to be taken from any available fund of the Office of the City Mayor in accordance with Section 28 of Republic Act No. 7279, otherwise known as the Urban Development and Housing Act of 1992.


