RESOLUTION NO. SP- **7127** , S-2017

A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT (QCG), REPRESENTED BY THE CITY MAYOR, HONORABLE HERBERT M BAUTISTA, TO ENTER INTO AND SIGN THE DEED OF USUFRUCT WITH THE OFFICE OF CIVIL DEFENSE REGIONAL OFFICE – NATIONAL CAPITAL REGION (OCDRO-NCR), SUBJECT TO EXISTING LAWS, RULES AND REGULATION.

WHEREAS, under Republic Act No. 7160, as amended, the Local Government Units are vested with authority to assist other government agencies to discharge their functions and responsibilities as mandated by law;

WHEREAS, Section 455 (b) (2) (vi) and Section 455 (b) (1) (ix) of Republic Act No. 7160 states that, "to enforce all laws and ordinance, the City Mayor shall: ↗

*"call upon the appropriate law enforcement agencies to suppress disorder, riot, lawless violence, rebellion or sedition, or to apprehend violators of the law when public interest so requires and the city police forces are inadequate to cope with the situation or the violators" and*




*"allocate and assign office space to city and other officials and employees who, by law or ordinance, are entitled to such space in the city hall and other buildings owned or lease by the city government."*

*WHEREAS, the Office of Civil Defense (OCD) is the implementing arm of the National Disaster Risk Reduction and Management Council and shall have the primary mission of administering a comprehensive national civil defense and disaster risk reduction and management program by providing leaders in the continuous development of strategic and systematic approaches as well as measures to reduce the vulnerabilities and risks to hazard and manage the consequences of disaster;*

*WHEREAS, the OCDRO-NCR has requested the QCG for an available Office Space to effectively and efficiently carry out their mandated functions and to operate on a 24/7 basis especially during times for disaster response during calamities and for community service and development;*

*WHEREAS, it has been agreed upon and with the consent of the concerned officer from the QCG as affirmed and accepted by the OCDRO-NCR that they shall be permitted to occupy and utilize as OFFICE SPACE ONLY, the Second Floor (2nd) Floor, Civic Center C Building adjacent to the Bureau of Immigration (BID) Satellite Office (Terms and Agreement are found in the Deed of Usufruct);*

*WHEREAS, there exist a necessity to authorize Mayor Herbert M. Bautista for the Quezon City Government (QCG) to enter into and sign the Usufructuary Agreement with the Office of Civil Defense Regional Office – National Capital Region (OCDRO-NCR). ✕*


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the Quezon City Government (QCG), represented by the City Mayor, Honorable Herbert M Bautista, to enter into and sign the Deed of Usufruct with the Office of Civil Defense Regional Office – National Capital Region (OCDRO-NCR), subject to existing laws, rules and regulations.


RESOLVED, FURTHER, that a copy of this Resolution be furnished to the Office of Civil Defense Regional Office – National Capital Region (OCDRO-NCR), for their information and guidance.

RESOLVED, FINALLY, that a copy of the Deed of Usufruct be made an integral part hereof.


