A RESOLUTION GRANTING A SPECIAL PERMIT TO MR. PERRY WEINNE LATO FOR THE OPERATION OF NDM BINGO CENTER/HALL 2, INC. AT LOT 9 BLOCK 12, COMMONWEALTH AVENUE, BARANGAY COMMONWEALTH, QUEZON CITY FOR PURPOSES OF HOLDING BINGO GAMES SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR).

*WHEREAS, Mr. Perry Weinne Lato is applying for a Special Permit for the operation of NDM Bingo Center/Hall 2, Inc. at Lot 9, Block 12, Commonwealth Avenue, Barangay Commonwealth, Quezon City;*

*WHEREAS, the Philippine Amusement and Gaming Corporation, (PAGCOR) granted Mr. Perry Weinne Lato an authority to operate an Electronic Bingo Center/Hall where bingo games may be played; †*

WHEREAS, under the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Council, through a Resolution, may grant Special Permits or Licenses;

WHEREAS, the authority to operate an Electronic Bingo Boutique granted herein shall be subject to the following limitations:

- a. The holding of Bingo games shall be in accordance with the Rules and Regulations promulgated by PAGCOR;
- b. The operation of Bingo Center/Hall shall not include the playing of games not related to or other than bingo;
- c. The operator is enjoined to prohibit individuals below 18 years of age from playing in the above-mentioned games.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, a Special Permit to Mr. Perry Weinne Lato for the operation of NDM Bingo Center/Hall 2, Inc. at Lot 9, Block 12, Commonwealth Avenue, Barangay Commonwealth Quezon City, for the purpose of holding bingo games subject to the Rules and Regulations promulgated by the Philippines Amusement and Gaming Corporation (PAGCOR).

RESOLVED, FURTHER, that the NDM Bingo Center/Hall 2 shall remit to the City Treasurer a franchise fee of three percent (3%) of the gross sales of the herein grantee which shall be made payable yearly to the City Treasurer during the lifetime of this measure. γ


