A RESOLUTION URGING THE DEPARTMENT OF TRADE AND INDUSTRY TO PUT UP A GO NEGOSYO CENTER WITHIN THE QUEZON CITY HALL COMPOUND.

WHEREAS, Section 3 of Republic Act No. 10644, otherwise known as "An Act Promoting Job Generation and Inclusive Growth through the Development Of Micro, Small and Medium Enterprises (Go Negosyo Act)" provides that, "There shall be established under the supervision of the Micro, Small and Medium Enterprise Development (MSMED) Council, a "Negosyo Center" in all provinces, cities and municipalities";

WHEREAS, the basic policy of "Go Negosyo Act" is to promote inclusive growth and reduce poverty by encouraging the establishment of MSMEs that facilitate local job creation, production and trade;

WHEREAS, Go Negosyo Centers provide a unified and simplified business registration through automatic approval of business permits and licenses that are not approved for any reason within fifteen (15) days;

WHEREAS, the establishment of a Go Negosyo Center within the Quezon City Hall compound would promote ease of doing business and facilitate access to services for MSMEs as it will provide a one-stop-shop that will greatly benefit micro, small and medium business entrepreneurs;

WHEREAS, there is already a Go Negosyo Center within Quezon City located in Ali Mall Cubao, specifically inside its Ali Mall Government Center. However, a Go Negosyo Center within the Quezon City Hall compound is more strategic and accessible to the public;


WHEREAS, there is no limit as to the number of Go Negosyo Centers that may be established in a province, city or municipality.

NOW, THEREFORE,


