WHEREAS, Megaworld Corporation, a corporation duly organized and existing under Philippine laws, with office address at the 7<sup>th</sup> Floor, No. 1880 Eastwood Avenue, Eastwood City Cyber Park, 188 E. Rodriguez Jr. Avenue, Bagumbayan, Quezon City, represented by its Commercial Division, Marketing and Business Development Head, Ms. Teresa Felicidad Pesigan - Valentino;

WHEREAS, the Local Government of Quezon City, a local government unit of the Republic of the Philippines, through the Office of the City Mayor, with office address at the 2<sup>nd</sup> Floor Legislative Wing Building, Quezon City Hall Compound, Elliptical Road, Barangay Central, Diliman Quezon City, 1100, represented by its City Mayor, Hon. 
