WHEREAS, after her mandatory retirement as Head of the Social Services Development Department, Ma. Teresa M. Mariano has been appointed as City Government Department Head III (Co-Terminus) by the City Mayor Herbert M. Bautista;


WHEREAS, Ma. Teresa M. Mariano possesses all the qualifications and none of the disqualifications to be appointed as City Government Department Head III (Co-Terminus) under the Office of the City Mayor of Quezon City;

WHEREAS, the confirmation of the appointment of Ms. Mariano as City Government Department Head III (Co-Terminus) under the Office of the City Mayor will complete the substantive and procedural requirements set forth by the Civil Service Rules and Regulations.


NOW, THEREFORE,


