A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO STA. LUCIA LAND, INC., FOR THE CONSTRUCTION OF THE TRIBUTE TOWER, A TWENTY ONE (21)-STOREY MIXED RESIDENTIAL AND CONDOTEL BUILDING AT SCOUT GANDIA STREET, BARANGAY SACRED HEART, KAMUNING, QUEZON CITY, ALLOWING DEVIATION FROM THE PARKING AND DENSITY REQUIREMENTS PROVIDED FOR UNDER THE PROVISIONS OF QUEZON CITY COMPREHENSIVE ZONING ORDINANCE NO. SP-918, S-2000, AS AMENDED, AND ITS IMPLEMENTING RULES AND REGULATIONS.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the issuance of a Certificate of Exception to Sta. Lucia Land, Inc. for the construction of The Tribute Tower, a Twenty One (21)-storey mixed Residential and Condotel building at Scout Gandia Street, Barangay Sacred Heart, Kamuning, Quezon City, allowing deviation from the parking and density requirements provided for under the provisions of the Quezon City Comprehensive Zoning Ordinance No. SP-918, S-2000, as amended, and its Implementing Rules and Regulation.
