RESOLUTION NO. SP- 7199, S-2017

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO EXTEND FINANCIAL ASSISTANCE TO THE MUNICIPALITIES OF BASCO, IVANA, ITBAYAT AND MAHATAO, ALL IN THE PROVINCE OF BATANES, IN THE AMOUNT OF TWELVE MILLION NINETY TWO THOUSAND THREE HUNDRED SEVEN PESOS AND FORTY EIGHT CENTAVOS (PHP12,092,307.48), TO BE TAKEN FROM THE QUEZON CITY DISASTER RISK REDUCTION AND MANAGEMENT FUND, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.

WHEREAS, Super Typhoon "Ferdie" with International Name "Meranti" was considered the strongest typhoon ever to hit the Province of Batanes in 2016 with a category No. 4 and with a maximum sustained winds of 220 kph near the center and gustiness of up to 255 kph that made a landfall on Itbayat, Batanes last September 14, 2016;

WHEREAS, among the municipalities devastated by Super Typhoon "Ferdie" in the Province of Batanes are the municipalities of Basco, Itbayat, Ivana and Mahatao;



WHEREAS, the QC Disaster Risk Reduction and Management Council approved Resolution No. 001, S-2017, entitled "A Resolution Adopting the municipalities in the Province of Batanes, namely Basco, Itbayat, Ivana and Mahatao as sister Local Government Units (LGUs) to be provided with financial and other means of humanitarian support by the Quezon City Government;

WHEREAS, Basco, Batanes Mayor Demetrius Paul C. Narag; Itbayat, Batanes Mayor Reuel C. Ibanes; Ivana, Batanes Mayor Leonardo V. Hostallero and Mahatao, Batanes Mayor William A. Agsunod wrote to the Honorable Herbert M. Bautista, Mayor of Quezon City requesting for financial assistance to be used in the repair and restoration of the various government infrastructure and facilities;

WHEREAS, in line with the aim of lending a helping hand and alleviating the lives of the people who were affected by typhoon "Ferdie" the following are the programs and detailed estimates for the proposed infrastructure projects damaged by Typhoon "Ferdie":

WHEREAS, Section 1, Rule 18 of the Implementing Rules and Regulations of Republic Act No. 10121, otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010, provides that upon the recommendation of the LDPPMC and approval of the Sanggunian concerned, the LDRRMCs may transfer the said fund to support the disaster risk reduction of other LDRRMCs which are declared under state of calamity.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to extend financial assistance to the Municipalities of Basco, Ivana, Itbayat, and Mahatao, all in the Province of Batanes, in the amount of Twelve Million Ninety Two Thousand Three Hundred Seven Pesos and Forty Eight Centavos (Php12,092,307.48), to be taken from the Quezon City Disaster Risk Reduction and Management Fund, subject to existing laws, rules and regulations.
