RESOLUTION NO. SP- 7227 , S-2017

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO GRANT FINANCIAL ASSISTANCE IN THE AMOUNT OF FIVE HUNDRED THOUSAND PESOS (PHP500,000.00), IN FAVOR OF THE PHILIPPINE CHAMBER OF COMMERCE AND INDUSTRY – NATIONAL CAPITAL REGION (PCCI-NCR), SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.

WHEREAS, Section 36. Assistance to People's and Non-Governmental Organizations. A local government unit may, through its local chief executive and with the concurrence of the Sanggunian concerned, provide assistance, financial or otherwise, to such people's and non-governmental organizations for economic, socially-oriented, environmental, or cultural projects to be implemented within its territorial jurisdiction;

WHEREAS, the Philippine Chamber of Commerce and Industry's (PCCI) vision is "to be the voice of Philippine business recognized by government and international institutions. As a pro-active catalyst of development, PCCI promotes and supports the drive for globally competitive Philippine enterprises in partnership with government, local chambers, and other business organizations";

WHEREAS, the main responsibility of PCCI is "to provide focused advocacy for business growth and sustainable development by providing business services for the advancement of grassroots entrepreneurship, chamber development, international trade relations, business innovation and excellence, and operating efficiency. These will be achieved through a professional organization working in close cooperation with various stakeholders in the public and private sector";

WHEREAS, on December 7, 1978 during the 4th Philippine Business Conference, the Palace issued Letter of Instruction No. 780 designating the PCCI as "Single Voice of Philippine Business.";

WHEREAS, Philippine Chamber of Commerce and Industry-National Capital Region (PCCI-NCR) will be holding their 25th Metro Manila Business Conference (MMBC) on 27th and 28th of July with the theme "Going Global and Embracing Change @ 25: A Celebration of Success";

WHEREAS, 25th Metro Manila Business Conference (MMBC) will be hosted by the PCCI NCR Central Sector composed of the City Chambers of Quezon City, Mandaluyong, Manila, Marikina, Pasig and San Juan with Dr. Hernando B Delizo of the PCCI-NCR as the Conference Director;

WHEREAS, it is a form of good governance to utilize the resources and/or funds of the City as efficiently and as effectively as possible to finance the delivery of basic services, and the enhancement of various social and economic activities for the prosperity and progress of the people of the City;

WHEREAS, Herbert M. Bautista, in his capacity as Mayor, acceded to assist the Philippine Chamber of Commerce and Industry - National Capital Region (PCCI-NCR), in every means necessary by donating the amount of Five Hundred Thousand Pesos (PhP500,000.00) for the success of the 25th Metro Manila Business Conference (MMBC) on 27th and 28th of July to be held at the Manila Hotel, Metro Manila. ✓


