RESOLUTION NO. SP-\_ 7228\_\_\_, S-2017

A RESOLUTION GRANTING A SPECIAL PERMIT TO GREEN ASIA RESOURCES CORPORATION, REPRESENTED BY WEINNE S. LATO, TO OPERATE AN NDM BINGO CENTER AT SPARK PLACE LOCATED AT P. TUAZON BOULEVARD CORNER 10<sup>TH</sup> AVENUE, CUBAO, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR).

WHEREAS, Green Asia Resources Corporation, a domestic corporation duly organized and existing under and by virtue of Philippine laws, represented by Mr. Weinne S. Lato, with principal office address at No. 1466 General Luna Street, Paco, Manila, is applying for a Special Permit to operate an NDM Bingo Center at Spark Place located at P. Tuazon Boulevard corner 10th Avenue, Cubao, Quezon City;

WHEREAS, to enable the applicant to operate the aforesaid NDM Bingo Center, there is a need to secure a Special Permit from the City Council pursuant to an existing city ordinance;

WHEREAS, Republic Act No. 7160. otherwise known as the Local Government Code of 1991, in relation to existing city ordinances, authorizes the City Council to grant Special Permit to business activity of the same nature.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant a Special Permit to Green Asia Resources Corporation, represented by Weinne S. Lato, to operate an NDM Bingo Center at Spark Place located at P. Tuazon Boulevard corner 10th Avenue. Cubao, Quezon City, subject to the Rules and Regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED, FURTHER, that the authority to operate NDM Bingo Center granted herein shall be subject to the following conditions:

- a) The holding of Bingo games shall be in accordance with the Rules and Regulations promulgated by PAGCOR;
- b) The operation of NDM Bingo Center shall not include the playing of games not related to or other than bingo;
- c) The operator is enjoined to prohibit individuals below eighteen (18) years of age from playing in the above-mentioned games.

RESOLVED, FINALLY, that this Special Permit to operate an NDM Bingo Center shall be valid for a period of three (3) years from the approval of this Resolution and maybe renewed by the City Council.
