WHEREAS, the State shall encourage non-formal, informal and indigenous learning system as well as self-learning, independent and out of-school study programs particularly those that respond to community needs;

WHEREAS, Republic Act No. 9155, otherwise known as the Government Act for Basic Education, provides for the establishment of the Alternative Learning System (ALS) to provide out-of-school children, youth and adults population with basic education;

WHEREAS, many young Filipinos do not have the chance to attend and finish formal basic education due to various reasons;

WHEREAS, since every Filipino has a right to free basic education and in order to encourage young Filipinos to finish formal basic education, Alternative Learning System (ALS), a parallel educational system, provides a practical option to the existing formal instruction;

WHEREAS, the 12 years of basic education provides for a senior high school with an aim to develop students to have sufficient skills and prepare graduates for tertiary education, middle-level skills development, employment, and entrepreneurship;

WHEREAS, the present Alternative Learning System (ALS) does not include the senior high school level of the K-12 Education System.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge the Department of Education (DepEd) to include Senior High School (Grade 11 and 12) in the Alternative Learning System (ALS).

RESOLVED, FURTHER, that a copy of this resolution be forwarded to the House of Representatives and the Senate of the Philippines for the adoption of necessary legislative measures.
