RESOLUTION NO. SP- 7238 ..., S-2017

A RESOLUTION GRANTING A SPECIAL PERMIT TO NDM BINGO CENTER 2, INCORPORATED, REPRESENTED BY PERRY WEINNE S. LATO, TO OPERATE AN E-BINGO GAMES AT LOWER GROUND FLOOR/SPACE, NO. BLS-02 SHOPKING, COMMONWEALTH AVENUE, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR).

Introduced by Councilor IVY XENIA L, LAGMAN.

WHEREAS, NDM Bingo Center 2, Inc., a domestic corporation duly organized and existing under and by virtue of Philippine laws, represented by Mr. Perry Weinne S. Lato, with principal office address at No. 1466 Gen. Luna Street, 673 Zone 73, Paco, Manila, is applying for a Special Permit to operate an E-Bingo Games at the Lower Ground Floor/Space, No. BLS-02 Shopking, Commonwealth Avenue, Quezon City;

WHEREAS, to enable the applicant to operate the aforesaid Bingo Games, there is a need to secure a Special Permit from the City Council pursuant to Ordinance No. SP-2285, S-2014, in relation to the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the aforesaid business activity will provide employment and additional revenue to the city government, thereby boosting the city's economy for the welfare of its inhabitants.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant a Special Permit to NDM Bingo Center 2, Inc., represented by Mr. Perry Weinne S. Lato, to operate an E-Bingo Games at the Lower Ground Floor/Space, No. BLS-02 Shopking, Commonwealth Avenue, Quezon City, subject to the Rules and Regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED, FURTHER, that the authority to operate an E-Bingo Games granted herein shall be subject to the following conditions:

- a. The holding of E-Bingo Games shall be in accordance with the Rules and Regulations promulgated by PAGCOR;
- b. The operation of E-Bingo Games shall not include the playing of games not related to or other than bingo;
- c. The operator is enjoined to prohibit individuals below eighteen (18) years of age from playing in the above mentioned games; and

RESOLVED, FINALLY, that this Special Permit to operate a Bingo Games shall be valid for a period of three (3) years from the approval of this Resolution and maybe renewed by the City Council.
