RESOLUTION NO. SP. 7241 , S-2017

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA TO EXTEND FINANCIAL ASSISTANCE OF FIVE THOUSAND PESOS (PHP5,000.00) TO EACH OF THE SEVEN HUNDRED (700) INFORMAL SETTLER FAMILIES (ISFs) AT NORTH TRIANGLE AREA, BARANGAY BAGONG PAG-ASA, QUEZON CITY, WHO ARE ABOUT TO BE RELOCATED TO NHA RESETTLEMENT SITES IN SAN JOSE DEL MONTE, BULACAN, EQUIVALENT TO A TOTAL AMOUNT OF THREE MILLION FIVE HUNDRED THOUSAND PESOS (PHP3,500,000.00).

WHEREAS, a total of 700 families (ISFs) who still occupy portions of the Quezon City Central Business District (QC CBD), specifically the North Triangle Area in Barangay Bagong Pag Asa, Quezon City;

WHEREAS, the National Housing Authority is responsible for the resettlement of the above-cited group of ISFs under its North Triangle Relocation and Resettlement Project (NTRRP) as stipulated under the Joint-Venture Agreement entered into by NHA and Ayala Land Corporation for the development of North Triangle Area;

WHEREAS, the Housing Community Development and Resettlement Department (HCDRD) of Quezon City, jointly with NHA, have already identified the qualified beneficiaries of financial assistance to be extended to the affected on-site ISFs at North Triangle Area;

WHEREAS, to draw cooperation from the affected ISFs and also to provide them with something to start with at the resettlement site, there is a need for the Quezon City Government to allocate and extend financial assistance fund to the 700 affected ISFs in the total amount of Php3,500,000.00 or an equivalent amount of Php5,000.00 per ISF;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160 otherwise known as the Local Government Code of 1991, states that, "the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance".

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista to extend financial assistance of Five Thousand Pesos (Php5,000.00) to each of the Seven Hundred (700) informal settler families (ISFs) at North Triangle Area, Barangay Bagong Pag-Asa, Quezon City, who are about to be relocated to NHA Resettlement Sites in San Jose Del Monte, Bulacan, equivalent to a total amount of Three Million Five Hundred Thousand Pesos (Php3,500,000.00).
