WHEREAS, the Quezon City Government is the owner of a condominium project now commonly known as Quezon City Housing Condominium, Phase II located in Barangay Bahay Toro, Quezon City which has been developed in line with the Quezon City's Housing Program and constructed by JC Resources Development;

WHEREAS, the Quezon City Government as the vendor of the said condominium project willingly sold Unit No. 33, 2nd Floor, Lot 9 of the Quezon City Housing Condominium, Barangay Bahay Toro, Quezon City, ntaining an area of twenty one square meters and fifteen decimeters (1.15sqm.) with Condominium Certificate Title No. 22306 of the Registry of Deeds of Quezon City, to Teodora D. Aviso as certified by the Certificate of Program Award issued on August 23, 1999 by then Mayor Ismael A. Mathay, Jr.;

WHEREAS, on March 2, 2017, the National Home Mortgage and Finance Corporation issued a Release of Real Estate Mortgage relative to the aforementioned property and by virtue of the Loan and Mortgage Agreement recorded under the Deed of Mortgage Entry No. 7881 CCT No. 22304 dated October 20, 2003.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to enter into and sign the Deed of Sale of Condominium Unit covered by Condominium Certificate of Title No. (CCT) 22306 of the Registry of Deeds of Quezon City, owned by the Quezon City Government in favor of Teodora D. Aviso.
