Domingo Ossuary) be located at Lot 4-B-3-C-2-A-3-A, No. 537 Quezon Avenue, Barangay Sto. Domingo, Quezon City;

WHEREAS, the proposed project will provide a viable and feasible Mausoleum and Garden Ossuary where the sealed bones and/or ashes of departed loved ones, with the name of Christ, can rest in peace in a strategic location, the Sto. Domingo Church;

WHEREAS, due to limited space in the city's private and public cemeteries, the proposed project is a timely undertaking to solemnly accommodate the remains of the said departed loved ones; y
