RESOLUTION NO. SP- **7256**, S-2017

A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO TOTAL (PHILIPPINES) CORPORATION FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE REFILLING STATION TO BE LOCATED AT P.B. DIONISIO AND CO., INC. PROPERTY, ALONG COMMONWEALTH AVENUE, BARANGAY MATANDANG BALARA, QUEZON CITY.

WHEREAS, Total Philippines Corporation, a corporation organized and existing under the laws of the Philippines, with principal office at the 7th Floor, 11th Corporate Center, 11th Avenue corner Triangle Drive, North Bonifacio, Bonifacio Global City, Taguig and represented by its President and Managing Director Mr. Philip Vaswani, is applying for the issuance of a Special Use Permit for the construction and operation of a Gasoline Refilling Station to be located at P.B. Dionisio and Co., Inc. property, along Commonwealth Avenue, Barangay Matandang Balara, Quezon City;

WHEREAS, gasoline refilling station is among the uses which require the issuance of a Special Use Permit upon authorization from the City Council pursuant to Section 52 of Ordinance No. 2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016;

WHEREAS, the proposed project or business activity will not adversely affect public health, safety and welfare of the citizenry. It will also provide and promote livelihood;

WHEREAS, the applicant has complied with the requirements for the issuance of a special use permit and that the Sangguniang Barangay, as well as the neighborhood concerned have interposed no objection for the aforesaid project. ✱




NOW, THEREFORE,


