Alferos holds a degree in Bachelor of Science in Commerce (BSC) major in Management, finished his Bachelor of Laws at the Far Eastern University (FEU) Institute of Law and passed the Bar Examinations in 2002;*

*WHEREAS, since his humble beginnings at the Sangguniang Panlungsod in 1997, Atty. Alferos has proven and performed his official duties and functions efficiently and served with diligence and devotion until his appointment to his current position as City Government Assistant Department Head III, under the Office of the Secretary to the Sangguniang Panlungsod;*


WHEREAS, Atty. John Thomas S. Alferos III possesses all the qualifications and none of the disqualifications to be appointed as Secretary to the Sanggunian;

WHEREAS, on August 8, 2017, the members of the Personnel Selection Board for the Legislative Department headed by the City Vice Mayor and Presiding Officer of the Sangguniang Panlungsod, Ma. Josefina G. Belmonte, concurred to his appointment, thus, adoption of this resolution is necessary.
