A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH THE CITY MAYOR, HOWOKABLE HERBERT M. BAUTISTA, TO PURCHASE FIVE (5) UNITS OF MOTOR VEHICLE INTENDED FOR THE MONITORING OF PROGRAMS AND PROJECTS OF THE OFFICE OF COUNCILOR RAMON P. MELIALIM AMOUNTING TO FIVE MILLION PESOS (PHP5,000,000.00) TO BE CHARGED AGAINST THE AVAILABLE FUNDS OF THE SAME OFFICE.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the Quezon City Government, through the City Mayor, Honorable Herbert M. Bautista, to purchase five (5) units of motor vehicle intended for monitoring purposes of the Office of Councilor Ramon P. Medalla, amounting to rive Million Pesos (Php5,000,000.00) to be charged against the available funds of the same office.
