RESOLUTION NO. SP 17, S-2017

A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE FIVE (5) UNITS OF MOTOR VEHICLE INTENDED FOR THE MONITORING OF PROGRAMS AND PROJECTS OF THE OFFICE OF COUNCILOR RAMON P. MEDALLA AMOUNTING TO FIVE MILLION PESOS (PHP5,000,000.00) TO BE CHARGED AGAINST THE AVAILABLE FUNDS OF THE SAME OFFICE.



WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991" the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the Quezon City Government, through the City Mayor, Honorable Herbert M. Bautista, to purchase five (5) units of motor vehicle intended for monitoring purposes of the Office of Councilor Ramon P. Medalla, amounting to five Million Pesos (Php5,000,000.00) to be charged against the available funds of the same office.
