**A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE ONE (1) UNIT OF MOTOR VEHICLE INTENDED FOR THE MONITORING OF PROGRAMS AND PROJECTS OF THE OFFICE OF COUNCILOR ERIC Z. MEDINA AMOUNTING TO ONE MILLION FOUR HUNDRED FORTY FIVE THOUSAND PESOS (PHP1,445,000.00), TO BE CHARGED AGAINST THE AVAILABLE FUNDS OF THE SAME OFFICE.**


NOW WHEREFORE,
