A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO JIMMY FARAON FOR THE CONSTRUCTION AND OPERATION OF A FARAON TAXI EXPRESS GARAGE LOCATED AT LOT 4 (#30-D) PUGAD LAWIN STREET, BARANGAY BAHAY TORO, QUEZON CITY.

WHEREAS, Jimmy Faraon is applying for a Special Use Permit for the construction and operation of a Faraon Taxi Express Garage located at Lot 4 (#30-D) Pugad Lawin Street, Barangay Bahay Toro, Quezon City;

WHEREAS, in accordance with the provision of Article VII Section 2 of Ordinance No. SP-918, S-2000 otherwise known as the Quezon City Comprehensive Zoning Ordinance, as amended, and its Implementing Rules and Regulations, a Special Use Permit is required for this project;

WHEREAS, the proposed project will not adversely affect the public health, safety and welfare of the citizenry. It will also provide and promote livelihood;

WHEREAS, the applicant has complied with all the requirements for the issuance of a Special Use Permit and Barangay Bahay Toro interposes no objection for the operation of the applicant's taxi garage and approves the conduct of its business in their area.


NOW, THEREFORE,


