A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO SELL ONE (1) UNIT OF MOTOR VEHICLE ASSIGNED TO FORMER CITY COUNCILOR CANDY A. MEDINA, THE PRICE OF WHICH IS TO BE DETERMINED BY THE CITY APPRAISAL COMMITTEE, SUBJECT TO AUDITING AND ACCOUNTING RULES AND REGULATIONS.

WHEREAS, Resolution No. 8630, S-71 of the Quezon City Council advocates for the sale of vehicle and equipment to government officials and employees should they be willing to purchase the same at the appraised value, provided that taxes due and payable to the government shall be shouldered by the purchaser;


WHEREAS, Councilor Candy A. Medina has expressed her intention to purchase her service vehicle because of its sentimental value;

WHEREAS, it will be advantageous to sell the above-described motor vehicle considering its costly maintenance and surpassed depreciation expense and book value.


NOW, THEREFORE,
