WHEREAS, petitioner Shell Service Station, a business entity duly registered under Philippine Laws, is applying for a Special Use Permit (SUP) to be used for the construction and operation of a gasoline filling station to be located at 20th Avenue corner P. Tuazon Boulevard, Quezon City;

WHEREAS, fuel stations are among the uses that require Special Use Permit upon authorization from the Quezon City Council pursuant to Ordinance No. SP 018, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2000, as amended;




