WHEREAS, Honorable Herbert M. Bautista, in his capacity as Mayor, acceded to assist the QCFBKF in every reasonable means by granting the request of the organization to donate the amount One Million Pesos (Php1,000,000.00) to carry out its mandate, projects and activities;

WHEREAS, the donation of the said amount is necessary to promote and provide support to a civic organization to attain its objectives.


NOW, THEREFORE,


