A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO CAUSE THE REPAIR AND MAINTENANCE OF ROADS LOTS, DRAINAGE SYSTEM AND OPEN SPACES OF RISING SUN VILLAGE, BARANGAY BAESA, QUEZON CITY PURSUANT TO THE PROVISIONS OF CITY ORDINANCE NO. SP-2298, S-2014, WHICH WERE ABANDONED BY THE SUBDIVISION DEVELOPER AS CERTIFIED BY THE CITY PLANNING AND DEVELOPMENT OFFICE.

WHEREAS, on June 5, 2017, the Homeowners Association of Rising Sun Village, Barangay Baesa, Quezon City made representation with the Quezon City Government to assist them in the improvements of their community;

WHEREAS, the subdivision developer, the Rising Sun, Inc., failed to turn-over the road lots and open spaces of Rising Sun Village to the Quezon City Government;

WHEREAS, the roads lots, drainage system and open spaces of Rising Sun Village, Baranggy Baesa are in bad conditions and need major repairs;

WHEREAS, City Ordinance No. SP-2298, S-2014 declared abandoned roads, alleys, open spaces and excess lots in all subdivisions in Quezon City as properties for public use by the City Government, thereby setting the guidelines for the use thereof and for other purposes;

WHEREAS, on July 3, 2017, the City Planning and Development Office certified that the Rising Sun Village is an abandoned subdivision pursuant to the provisions of City ordinance No. SP-2298, S-2014.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to cause the repair and maintenance of roads lots, drainage system and open spaces of Rising Sun Village, Barangay Baesa, Quezon City pursuant to the provisions of City Ordinance No. SP-2298, S-2014, which were abandoned by the subdivision developer as certified by the City Planning and Development Office.
