A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO SIGN AND ACCEPT THE DEED OF DONATION AND ACCEPTANCE IN BEHALF OF THE QUEZON CITY GOVERNMENT, WITH SALVACION PILARES ET.AL., REPRESENTED BY THEIR ATTORNEY-IN-FACT, RICARDO C. PILARES, JR. CONSISTING OF THREE (3) ROAD LOTS AND EIGHT (8) ALLEYS LOCATED AT BARANGAY CULIAT, QUEZON CITY.

WHEREAS, the registered owners and heirs of the abovementioned property hereby transfers, cedes and conveys by way of this Deed of Donation and Acceptance in favor of the Quezon City Government, all the rights, interest and title of the said parcel of land, free from all liens and encumbrances.
