RESOLUTION NO. SP. 7342, S-2018

A RESOLUTION GRANTING A SPECIAL PERMIT TO JACBINGO CORPORATION, REPRESENTED BY MR. ANTONIO G. TENG, TO OPERATE A BINGO CENTER/HALL AT JACKMAN PLAZA-MUÑOZ LOCATED AT NO. 1038 EDSA, BARANGAY RAMON MAGSAYSAY, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR).

WHEREAS, JACBINGO Corporation, a domestic corporation duly organized and existing under and by virtue of Philippine laws, represented by Mr. Antonio G. Teng, with principal office address at No. 1038 EDSA corner Muñoz, Barangay Ramon Magsaysay, Quezon City, is applying for a Special Permit to operate a Bingo Center/Hall in the same business address;

WHEREAS, to enable the applicant to operate the aforesaid Bingo Center/Hall, there is a need to secure a Special Permit from the City Council pursuant to an existing city ordinance;

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, in relation to existing city ordinances, authorizes the City Council to grant special permit to business activity of the same nature.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant a Special Permit to JACBINGO Corporation, represented by Mr. Antonio G. Teng, to operate a Bingo Center/Hall at Jackman Plaza-Muñoz located at No. 1038 EDSA, Barangay Ramon Magsaysay, Quezon City, subject to the Rules and Regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED, FURTHER, that the authority to operate Bingo Center/Hall granted herein shall be subject to the following conditions:

- a. The holding of Bingo games shall be in accordance with the Rules and Regulations promulgated by PAGCOR;
- b. The operation of Bingo Center/Hall shall not include the playing of games not related to or other than bingo;
- c. The operator is enjoined to prohibit individuals below eighteen (18) years of age from playing in the abovementioned games.

RESOLVED, FURTHERMORE, that JACBINGO Corporation shall remit to the City Treasurer's Office a franchise fee of three percent (3%) of the gross revenue of herein grantee, which shall be payable yearly to the City Treasury during the lifetime of this measure

RESOLVED, FINALLY, that this Special Permit to operate a Bingo Center/Hall shall be valid for a period of two (2) years from the approval of this Resolution and may be renewed by the City Council.
