A RESOLUTION ENDORSING TO THE PHILIPPINE ECONOMIC ZONE AUTHORITY (PEZA) THE APPLICATION OF FILINVEST CYBERPARKS, INC., FOR THE DECLARATION OR ACCREDITATION OF THEIR BUILDING LOCATED ALONG EDSA, DILIMAN, QUEZON CITY AS THE INFORMATION TECHNOLOGY (IT) BUILDING TO BE KNOWN AS "STUDIO 7".

WHEREAS, the Filinvest Cyberparks, Inc. (FCI) has applied for the grant of a pre-qualification clearance for the declaration of a building with 18 floors plus roof-deck which shall stand on a 4,800-square meter lot located along EDSA, Diliman, Quezon City as Information Technology (IT) Building and the same was approved through PEZA Resolution No. 17-223;

WHEREAS, pursuant to Section 3, Rule IV of the PEZA Rules, as amended, and under PEZA Board Resolution No. 00-411, an Endorsement from the Sangguniang Panlungsod is necessary prior to the issuance of a Presidential Proclamation declaring such FCI Building as IT Building;

WHEREAS, the subject FCI Building will further boost Quezon City's position as the IT Capital of the country considering that the site thereof may be deemed as Ecozones or Special Economic Zones dealing on tourist and recreational centers;

WHEREAS, the establishment of FCI Information Technology (IT) Building would attract more information-based companies and will be instrumental in raising the city's revenues.
