RESOLUTION NO. SP-7365, S-2018

A RESOLUTION URGING THE CITY PLANNING AND DEVELOPMENT OFFICE AND THE CITY ENGINEERING DEPARTMENT TO DEVELOP A PROJECT CONCEPT OR PROPOSAL FOR THE CONSTRUCTION OF CAUSEWAY WITHIN THE EASEMENT ALONG THE STRETCH OF TULLAHAN RIVER TO SERVE AS A NEW ROADWAY TO HELP DECONGEST TRAFFIC IN QUEZON CITY.

WHEREAS, Tullahan River is a 15-kilometer river starting from the La Mesa reservoir in Quezon City and flows through Caloocan City, Malabon and Valenzuela City;

WHEREAS, the river has an average width of 20.00 (m) with an easement of 6 meters on both sides of the river and traverses the Barangays of Greater Fairview, North Fairview, Novaliches Proper, San Agustin, Sta. Lucia, Sta. Monica, Nagkaisang Nayon, Gulod, San Bartolome, Bagbag and Talipapa in Quezon City;

WHEREAS, traffic congestion is undeniably a long standing problem in Metro Manila. Factors such as volume of cars and lack of

new roads and alternate routes contribute to and aggravate traffic situations in major thoroughfares in the metropolis and Quezon City is not spared from this and makes everyday experience of motorists and commuters alike intolerable and hard;

WHEREAS, there is a need to develop new roads and alternate routes to help solve the traffic problem in Quezon City and the stretch of Tullahan River may serve the purpose;

WHEREAS, the construction of causeway within the easement along the stretch of Tullahan River in the vicinity of Quezon City will help develop a new and alternate road for motorists and commuters;

WHEREAS, as a necessary step, there is a need to develop a project concept or proposal for the aforementioned project.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge the City Planning and Development Office and the City Engineering Department to develop a project concept or proposal for the construction of causeway within the easement along the stretch of Tullahan River to serve as a new roadway to help decongest traffic in Quezon City
