BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the Quezon City Government through the City Mayor, Honorable Herbert M. Bautista, to purchase one (1) unit of motor vehicle intended for the monitoring of the programs and projects of the Office of Councilor Oliviere T. Belmonte to be charged to the Office of the City Councilor's Fund, Quezon City.
