A RESOLUTION AMENDING RESOLUTION NO. SP-7050, S-2017, ENTITLED "A RESOLUTION AUTHORIZING THE CITY MAYOR HONORABLE HERBERT M. BAUTISTA, TO PURCHASE ONE (1) UNIT OF MOTOR VEHICLE INTENDED FOR THE MONITORING OF PROGRAMS AND PROJECTS OF THE OFFICE OF COUNCILOR RAQUEL S. MALAÑGEN, AMOUNTING TO ONE MILLION FOUR HUNDRED FIFTY THOUSAND PESOS (PHP1,450,000.00)", HEREIN REPLACING THE APPROVED AMOUNT TO TWO MILLION PESOS (PHP2,000,000.00).

WHEREAS, Resolution No. SP-7050, S-2017 was confirmed last March 27, 2017, however, while undergoing the lawful process of procuring the said motor vehicle, a substantial increase in the price of the vehicle was implemented by virtue of Republic Act No. 10963, otherwise known as the "Tax Reform for Acceleration and Inclusion Law" (TRAIN Law).

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to amend, as it does hereby amend Resolution No. SP-7050, S-2017, entitled "A Resolution authorizing the City Mayor, Honorable Herbert M. Bautista, to purchase One (1) unit of motor vehicle intended for the monitoring of programs and projects of the Office of Councilor Raquel S. Malangen, amounting to One Million Four Hundred Fifty Thousand Pesos (Php1,450,000.00)", herein replacing the approved amount to Two Million Pesos (Php2,000,000.00).
