A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO GRANT FINANCIAL ASSISTANCE IN THE AMOUNT OF EIGHT HUNDRED THOUSAND PESOS (PHP800,000.00) TO THE ROTARY CLUB OF KAMUNING DISTRICT 3780 ASSOCIATION, INC., SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.

WHEREAS, the Rotary Club of Kamuning located at RI District 3780 Roces Avenue corner Mother Ignacia Street, Quezon City is a community service club affiliated with Rotary International District 3780, Quezon City and as such, has been undertaking its signature service project every year since 1994, dubbed as the "Alay ng Rotary sa Araw ng Kabataan" (ALAY), where 3,000 to 4,000 elementary and high school students from the different public schools in Quezon City participate yearly to compete in various Philippine cultural, music, and arts activities;

WHEREAS, the Rotary Club of Kamuning is an organization duly accredited by the Quezon City Community Relations Office (CRO);

WHEREAS, the Rotary Club of Kamuning seeks financial assistance to the Quezon City Government through the City Mayor Herbert M. Bautista in the amount of Eight Hundred Thousand Pesos (Php800,000.00) to be utilized for its annual project, "Alay ng Rotary sa Araw ng Kabataan" (ALAY) which will be participated by 142 public schools in Quezon City;


WHEREAS, Section 36 of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991" expressly provides:

"Secion 36. Assistance to People's and Non-Governmental Organizations. - A local government unit may, through its local chief executive and with the concurrence of the sanggunian concerned, provide assistance, financial or otherwise, to such people's and non-governmental organizations for economic, socially-oriented, environmental, or cultural projects to be implemented within its territorial jurisdiction".


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to grant financial assistance in the amount of Eight Hundred Thousand Pesos (Php800,000.00) to the Rotary Club of Kamuning District 3780 Association, Inc., subject to existing laws, rules and regulations.
