RESOLUTION NO. SP. 7396, S-2018

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO AYALA LAND, INC. FOR THE CONSTRUCTION OF "NORTH STAR," A FORTY (40)-STOREY OFFICE BUILDING WITH SIX (6) BASEMENT PARKING TO BE LOCATED AT LOT 3 VERTIS DRIVE, NORTH TRIANGLE, BARANGAY BAGONG PAG-ASA, QUEZON CITY, ALLOWING DEVIATION FROM THE REQUIREMENTS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016.

WHEREAS, Ayala Land, Inc., represented by Ms. Catleya L. Moya, is applying for a Certificate of Exception for the construction of a forty (40)-storey office building with six (6) basement parking to be located at Lot 3 Vertis Drive, North Triangle, Barangay Bagong Pag-asa, Quezon City;

WHEREAS, based on the Notice/Advice of Action issued by the City Planning and Development Office, the proposed project does not conform with the City's existing zoning ordinance;

WHEREAS, pursuant to Paragraph 2, Section 55, Article VIII of Ordinance No. SP-2502, S-2016, an Exception is required for the aforesaid project only upon authorization from the City Council;

WHEREAS, the applicant is required to allot in their proposed project five (5) percent of the total parking lot/space exclusively for the use of visitors, clients or customers as mandated by Ordinance No. SP-2582, S-2017;

WHEREAS, the proposed project will not adversely affect public health, safety, and welfare and is in keeping with the general pattern of development in the community;  $\chi$

WHEREAS, the applicant has complied with the necessary requirements prescribed by law, ordinance or administrative issuances.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the issuance of a Certificate of Exception to Ayala Land, Inc. for the construction of "North Star", a forty (40)-storey office building with six (6) basement parking to be located at Lot 3 Vertis Drive, North Triangle, Barangay Bagong Pag-Asa, Quezon City, allowing deviation from the requirements provided under Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016.
