WHEREAS, operating electronic games is among the business establishments that require a Special Permit to be granted by the Quezon City Council in accordance with the provisions of Section 2, Article VIII of Ordinance No. SP-2200, S-2013, otherwise known as the Revised Quezon City Comprehensive Zoning Ordinance and its implementing Rules and Regulations;

WHEREAS, Glorious Throne Data Company, Inc., has complied with the necessary requirements for the issuance of Special Permit as mandated by the aforementioned ordinance;

WHEREAS, the Office of the City Mayor through the BPLO Chief, Mr. Garry Domingo interposes no objection to the gaming studio of the petitioner by issuing a letter of no objection dated March 24, 2017;

WHEREAS, the Sangguniang Barangay of Barangay Ugong Norte issued Barangay Resolution No. 17, S-2018 dated February 20, 2018 for the said project, interposing no objection.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the issuance of a Special Permit to Glorious Throne Data Company, Inc., for the operation of a Gaming Studio for E-Bingo Electronic Gaming Data Streaming at 2/F Exxa and Zeta Towers, Bridgetowne, C-5 Road, Ugong Norte, Quezon City.

RESOLVED, FURTHER, that the PAGCOR licensed Glorious Throne Data Company, Inc. shall remit to the City Treasurer's Office a franchise fee of three percent (3%) of the annual gross administrative and operations commissions, payable annually to the City Treasury during the lifetime of this measure. ✓
