RESOLUTION NO. SP. 7400 , S-2018

A RESOLUTION RENEWING THE SPECIAL PERMIT OF THISISIT GAMING INC. TO ESTABLISH AN INTEGRATED SPORTS BETTING AND GAMING HUB AT NO. 67 TIMOG AVENUE, QUEZON CITY, FOR THE OPERATION OF E-BINGO MACHINES, INSTAWIN/E-GAMES STATION, OFF-TRACK BETTING STATION, SPORTS BETTING STATION, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR) AND THE GAMES AND AMUSEMENT BOARD (GAB).

WHEREAS, ThisIsIt Gaming, Inc. is a domestic corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, represented by Ms. Verna V. Mariano, with principal office at the Ground Floor Pacific Century Tower Building, No. 1472-1476 Quezon Avenue, South Triangle, Quezon City;

WHEREAS, to enable the applicant to operate an integrated sports betting and gaming hub in Quezon City, there is a need to secure a Special Permit from the City Council pursuant to Ordinance No. SP 2285, S-2014, in relation to the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, ThisIsIt Gaming, Inc. is earnestly requesting the City Council to grant a Special Permit to operate an integrated sports betting and gaming hub that includes the operation of E-Bingo Machines, Instawin/E-Games Station, Off-Track Betting Station and Sports Betting Station;

WHEREAS, the operation of E-Bingo Machines, Instawin/ E-Games Station, and Sports Betting Station is regulated and licensed by the PAGCOR, while the operation of an Off-Track Betting Station is regulated by the Games and Amusements Board (GAB);

WHEREAS, ThisIsIt Gaming, Inc. was previously granted a Special Permit when they first operated a sports bar at Pacific Century Tower Building, Quezon Avenue, Barangay South Triangle, Quezon City;

WHEREAS, the aforesaid business activity will provide employment and additional revenue to the City Government, thereby boosting the city's economy.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to renew, as it does hereby renew, the Special Permit of ThisIsIt Gaming, Inc. to establish an integrated Sports Betting and Gaming Hub at No. 67 Timog Avenue, Quezon City, for the operation of E-Bingo Machines, Instawin/E-Games Station, Off-Track Betting Station, Sports Betting Station, subject to the rules and regulations promulgated by the PAGCOR and GAB.

RESOLVED, FURTHER, that ThisIsIt Gaming, Inc. shall remit to the City Treasurer's Office a franchise fee of three percent (3%) of the gross revenue of herein grantee, which shall be made payable yearly to the City Treasury during the lifetime of this measure.

RESOLVED, FINALLY, that the authority herein granted shall be for a period of two (2) years and maybe renewed by the City Council.
