A RESOLUTION AUTHORIZING THE NOVALICHES DISTRICT HOSPITAL (NDH) TO OPEN AN ACCOUNT WITH LANDBANK OF THE PHILIPPINES FOR THE AUTO-CREDIT PAYMENT SCHEME OF ALL PHILHEALTH CLAIMS, PURSUANT TO PHILHEALTH CIRCULAR NO. 2017-0020, AMENDING FOR THE PURPOSE PHILHEALTH CIRCULAR NO. 43, S-2012.

WHEREAS, PhilHealth Circular No. 2017-0020 provides for the process and implementation of Auto-Credit Payment Scheme (ACPS) to all PhilHealth Care Institutions, amending for the purpose PhilHealth Circular No. 43, S-2012, entitled "Reimbursement for Hospital Claims through Auto-Credit Payment Scheme", whereby payment of the claims of health care institutions (HCPs) is credited directly through its designated deposit account with the partner bank;

WHEREAS, the objectives of this policy is to improve claim process efficiently by automating PhilHealth's payment mechanism with the HCP's banking service providers. This likewise guides HCP's by prescribing standard requirements for HCI autocredit registration, official receipt information, and autocredit payment schedules;


NOW, THEREFORE,


