WHEREAS, on October 26, 2017, at about 6:25 in the evening at Block 4, Lot 2, Marytown Circle, Greenfields I, Barangay Kaligayahan, Novaliches, Quezon City, armed with an arrest warrant, the combined operatives of the Quezon City Police District and the Armed Forces of the Philippines (AFP) Naval Intelligence Service Group arrested 42-year old Rasdy Malawani aka Rasdi Macabangkit/Makabanket who has been under surveillance for fronting for Ominta Romato Maute, alias Farhana of the Maute-ISIS inspired terrorist group;

WHEREAS, the suspect was found to be managing the Salaam Bazaar in Novaliches Plaza Mall, which was identified as a source of financing of the terrorist group in Marawi City. Farhana is now in detention at the Bicutan Jail, after being arrested in Barangay Karmatan, Masiu, Lanaodel Sur last June, 2017;

WHEREAS, the relentless efforts of the combined operatives and intelligence operations established that the suspect was running the bazaar and collecting rentals from the stallholders and remitted the same to Azesha/Azezza Macabangkit-Maute, alias Lily, the wife of Madie Maute who was among the architects of the Marawi siege;

WHEREAS, the arrest of the suspect will cripple the business at the Novaliches Plaza Mall run by Malawani for the Maute's matriarch which was a significant financial source of the dreaded terrorist group;

WHEREAS, the combined efforts of the Philippine National Police and the Armed Forces of the Philippines was truly an admirable dedication, courage, determination and discipline in their respective pursuits and truly deserving of national admiration and recognition.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to convey, as it does hereby convey the highest recognition and commendation to the Quezon City Police District (QCPD) headed by Police Chief Superintendent Guillermo Lorenzo T. Eleazar and the combined personnel of District Special Operations Unit (DSOU) led by P/Supt. Rogarth Campo, District Intelligence Division (DID) under P/Supt. Pedro Sanchez, Fairview Police Station (PS-5) under P/Supt. Tomas Nuñez and the operatives of the National Intelligence Coordinating Agency-NCR/CTIC (NICA) and the Armed Forces of the Philippines (AFP) Naval Intelligence Service Group-NCR (NISG) and U2, JTF-NCR for the arrest of a trader fronting for Maute Terrorist Group.
