RESOLUTION NO. SP- 7404, S-2018

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO MS. MERCILY Y. ABRANTES FOR THE CONSTRUCTION OF A THREE (3)-STOREY SCHOOL BUILDING (AS BUILT) TO BE NAMED AS "PAISLEY GARDEN ACADEME OF QUEZON CITY, INC.", LOCATED AT LOT 15, BLOCK 10, PANTABANGAN STREET, NIA VILLAGE, BARANGAY SAUYO, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS OF ORDINANCE NO. SP-2502 S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016.

WHEREAS, Ms. Mercily Y. Abrantes is applying for a Certificate of Exception for the construction of a three (3)-Storey School Building (As Built) to be named as "Paisley Garden Academe of Quezon City, Inc., located at Lot 15, Block 10, Pantabangan Street, NIA Village, Barangay Sauyo, Quezon City;

WEHREAS, the subject school building has already been built and operational and will only need an additional floor to complete its three (3)-storey structure;

WHEREAS, in accordance with the provisions of Section 55, Article VIII, in relation to Sections 71 and 73, Article IX of Ordinance No. SP-2502, S-2016, an Exception or deviations from the provisions of Zoning Ordinance may be allowed only upon authorization from the City Council; ✓

WHEREAS, it will likewise support economic-based activities, provide livelihood, and poses no adverse effect on the zone or community considering that the purpose of construction is for a school building;

WHEREAS, the applicant has complied with the necessary requirements prescribed by law, ordinance, and pertinent administrative issuances.


NOW, THEREFORE,


