A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE ONE (1) UNIT OF MOTOR VEHICLE INTENDED FOR THE IMPLEMENTATION, OPERATION, AND MONITORING OF PROJECTS AND PROGRAMS OF THE OFFICE OF COUNCILOR IVY XENIA LIM-LAGMAN IN THE AMOUNT OF ONE MILLION SIX HUNDRED EIGHTY THOUSAND PESOS (PHP1,680,000.00).


