WHEREAS, the Iglesia Ni Cristo strives to maintain a high moral standard as it regards the teachings of the Bible as a way of life, promoting purity of life among its members by means of instructions, reminders, and, when necessary, corrective or disciplinary measures;

WHEREAS, the Iglesia Ni Cristo and its partner, Felix Y. Manalo Foundation, undertook the obligation to deliver and provide basic medical, dental and relief assistance to those in need here in the Philippines and elsewhere in the world;

WHEREAS, the Iglesia Ni Cristo and its partner, Felix Y. Manalo Foundation, conducted one of its largest and widest-reaching "Lingap sa Mamamayan" socio-civic program as part of the 62nd birthday celebration of INC Executive Minister Brother Eduardo V. Manalo on October 31, 2017 not only in the country but also in selected areas abroad;

WHEREAS, the simultaneous holding of free medical, dental and the distribution of "goodie bags" which included home essentials, medicines and basic goods was conducted on October 29, 2017 at two sites in Metro Manila as well as in 104 other areas all over the country and several locations abroad. It was held in Barangay Maharlika, Taguig City and in Barangay Culiat in Quezon City. It is worthy to note that these areas are Muslim-dominated areas;

WHEREAS, overall, approximately 400,000 goodie bags were distributed in this historic outreach activity which was in response to the directives of the Executive Minister to the church officials to intensify its anti-poverty projects, particularly the Lingap sa Mamamayan program under the Felix Y. Manalo (FYM) Foundation;

WHEREAS, the Iglesia Ni Cristo under the leadership of Ka Eduardo V. Manalo gave "much emphasis on the Church's socio-civic and outreach activities", which seek to benefit not just INC members, but also less fortunate communities around the country and all over the world who need help, is worthy of commendation from the Quezon City government.
