WHEREAS, Section 14, Article II of the 1987 Philippine Constitution provides that "The State recognizes the role of women in nation-building, and shall ensure the fundamental equality before the law of women and men;"

WHEREAS, Section 2 of Republic Act No.9710, otherwise known as an act providing for the Magna Carta for Women provides that "The State recognizes the economic, political, and socio cultural realities that affect women in nation-building and shall promote empowerment of women;"

WHEREAS, Section 36 of Republic Act No.9710 also provides that "All local government units and other government instrumentalities shall adopt gender mainstreaming as a strategy to promote women's human rights and eliminate gender discrimination in their systems, structures, policies, programs, processes, and procedures;"

WHEREAS, in the same section of Republic Act No.9710, it also provides that "All local government units and other government instrumentalities shall establish or strengthen their GAD Focal Point System or similar GAD mechanism to catalyze and accelerate gender mainstreaming within the agency or local government unit;"

WHEREAS, Section 3, Article II of Ordinance no. SP-2501, S-2016, entitled "AN ORDINANCE AMENDING ORDINANCE NO. SP-1401, S-2004, ENTITLED "AN ORDINANCE PROVIDING FOR A CITY GENDER AND DEVELOPMENT CODE AND FOR OTHER PURPOSES" TO HARMONIZE WITH THE PROVISIONS OF REPUBLIC ACT NO. 9710, OTHERWISE KNOWN AS THE MAGNA CARTA FOR WOMEN AND TO ADOPT THE UN'S SAFE CITIES AND SAFE PUBLIC SPACES INITIATIVE", provides the definition for Gender Mainstreaming which refers to the strategy for making women's as well as men's concerns and experiences an integral dimension of the design, implementation, monitoring, and evaluation of policies and programs in all social, political, civil, and economic spheres so that women and men benefit equally, and to ensure that inequality is not perpetuated. It is the process of assessing the implications for women and men of any planned action, including legislation, policies or programs in all areas and at all levels;

WHEREAS, to achieve state declarations and policies with regard to the abovementioned laws as well as to promote, establish and strengthen the Gender and Development (GAD) Focal Point System to catalyze and accelerate gender mainstreaming, by conducting a job fair on March 8, 2018 for women in celebration of women's month, to give recognition to all women of Quezon City and to promote the advocacy of the same.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge the Public Employment Service Office (PESO) to conduct a job fair in celebration of Women's Month in March 2018.
