RESOLUTION NO. SP. 7431 , S-2018

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO INNO REALTY CORP., FOR THE CONSTRUCTION OF A THREE (3)-STOREY COMMERCIAL/DORMITORY BUILDING WITH DECK LOCATED AT LOT 12/BLOCK D-2 (#6) MOLAVE STREET, BARANGAY QUIRINO 3-A, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS OF ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016.

WHEREAS, Inno Realty Corporation is applying for a Certificate of Exception for the construction of a three (3) storey commercial/dormitory building located at Lot 12/Block D-2 (#6) Molave Street, Barangay Quirino 3-A, Quezon City;

WHEREAS, the proposed Project will not adversely affect public health, safety and welfare and is in keeping with the general pattern of development in the community;

WHEREAS, the Sangguniang Barangay of Barangay Quirino 3-A and its residents interposed no objection to the said project;

WHEREAS, in accordance with the provisions of Section 55, Article VIII, in relation to Section 71 and 73, Article IX of Ordinance No. SP-2502, S-2016, an Exception is required for projects to which the proposed undertaking falls under;

WHEREAS, the applicant shall comply with the provisions of Ordinance No. SP-2582, S-2017, otherwise known as "An ordinance mandating the owners/developers of a building either condominium or office building seeking exception from parking lot requirements to provide at least a minimum of five percent (5%) of the total parking lot/space requirements pursuant to Quezon City Comprehensive Zoning Ordinance exclusively for the use of visitors, clients or customers."

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the issuance of a Certificate of Exception to Inno Realty Corp., for the construction of a three (3)-storey commercial/dormitory building with Deck located at Lot 12/Block D-2 (#6) Molave Street, Barangay Quirino 3-A, Quezon City, allowing deviation from the restrictions of Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016.
